REACH Compliance Declaration

The EC Regulation No. 1907/2006 on Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) entered in force on June 1, 2007 and subject to amendments. The identification of a substance as a Substance of Very High Concern (SVHC) and its inclusion in the Candidate List creates certain legal obligations for the importers, producers and suppliers of an article that contains such a substance.

REACH defines an article as an object which during production is given a special shape, surface or design that determines its function to a greater degree than its chemical composition. The list is frequently amended and is available from <http://echa.europa.eu/web/guest/candidate-list-table>.

The business is a downstream user and as such we are liable for communication of information towards our customers, we are not liable for registration of substances. Chemical substances contained in our products, which may possibly be subject to registration, have to be registered by our suppliers who in turn must advise us about content.

We maintain contact with our suppliers to avoid SVHC materials being included in our products. They are also required annually to provide a statement against the latest candidate listing. Based on the response statements of our suppliers no materials from the ECHA Candidate List are included in our products or packages. Should it be found that our products or packages contain SVHC materials in the future, we will inform our customers immediately.

RoHS Compliance Declaration

Our products do not contain any homogeneous material that specifically:

- (Applications exempted from the prohibition in Article 4(1) sections 6a, 6b & 6c 2002/95/EC Commission Decision 2010/571/EU of 24 September 2010 and associated corrigendum referring to alloying elements)

The product as it is sold is exempt from the directive but as a supplier of cable gland products to industries that may be affected by the directive. Peppers Cable Glands Ltd can confirm that to the best of our knowledge at the date of this statement, none of the products we supply contain any substances in excess of permitted levels referred to therein.
